The technology is a compact automated diagnostic tool designed for performing hematology tests, its intended to use for small to mid-size laboratories. The device run different kind of heamtology tests such as blood cells counting, white blood cells differentials, platelet counts by using advanced flow cytometry technology. The device is CE marked.
