

### Standard 3 - Patient Allergies – Non Drug Allergies

Analysis of the current EMRs in the market and their workflows has highlighted a concerning gap in the recording of allergy information and a lack of common coding standard for drug and non-drug allergies. The incomplete documentation of allergies is seen across the following allergy parameters: allergy type, description, severity and reaction. Of the provider data analysed, approximately 50% of participants are entering allergies as free text, which means that there is no clinical decision support at the time of prescribing medications.

Therefore, in order to support an improved clinical decision support and e-prescribing process, it is required that the following allergy data fields are captured routinely at all healthcare facilities in a structured format. As part of a phased approach, the initial mandate is to capture Non-drug allergy information using SNOMED as the coding system and ensuring that the following required data is captured routinely

The Ministry of health And Prevention has recently procured an UAE wide SNOMED clinical terminologies license which means that all healthcare facilities will have access to this clinical terminology codeset. The SNOMED Codeset can be accessed from <link> using the credentials of your facility
